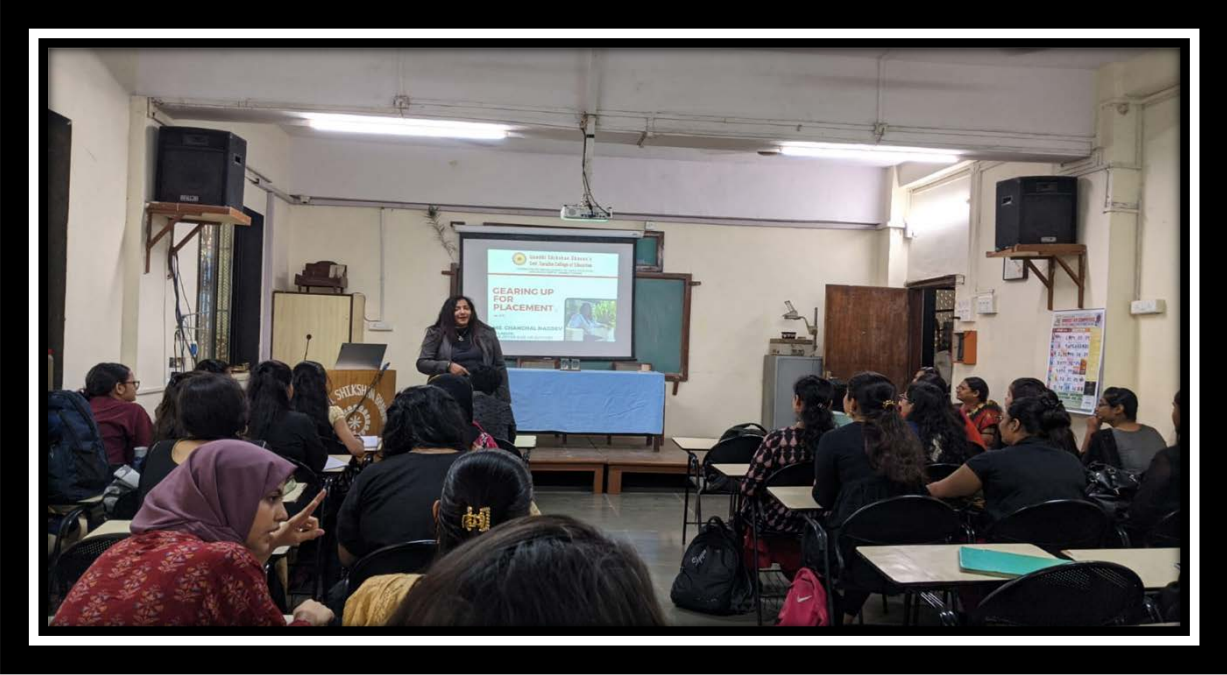
Report of the Placement Cell - 2022-2023

The students were made aware about all the aspects of TET / CTET examination with sample questions, tips for right preparation strategy examinations.
- 2) Gearing up for placement -Training workshop- A training workshop Gearing Up for placement was organised on 19th and 20th January 2023. Smt. Chanchal Nagdev, Founder of organisation The other side HR services was the resource person for this session. Variety of topics such as good resume writing, pre interview preparations, attire and body language, on line and offline interview do and don'ts, mock interviews, post interview follow ups were covered. It was a very interactive workshop.
- 3) Placement interviews – various educational institutions were contacted for placement of our students. Many of our students are placed in institutions like Aray Vidya mandir, Samata Vidya mandir, Hansaraj Morarji High School, National English high school, Rustamji Cambrige International School, Learner's Academy, R. N. Seth Vidyamandir, Samarth International School, Witty international etc. The range of offered salaries are from Rs. 42 thousand to 15 thousand. The efforts were being made to give placement opportunities to students.

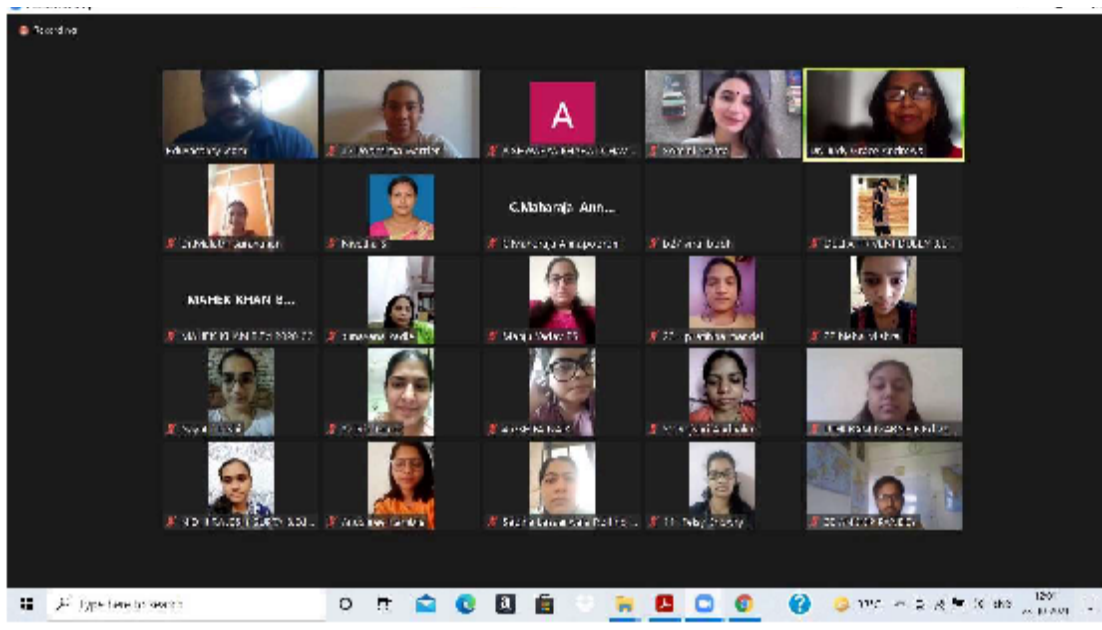
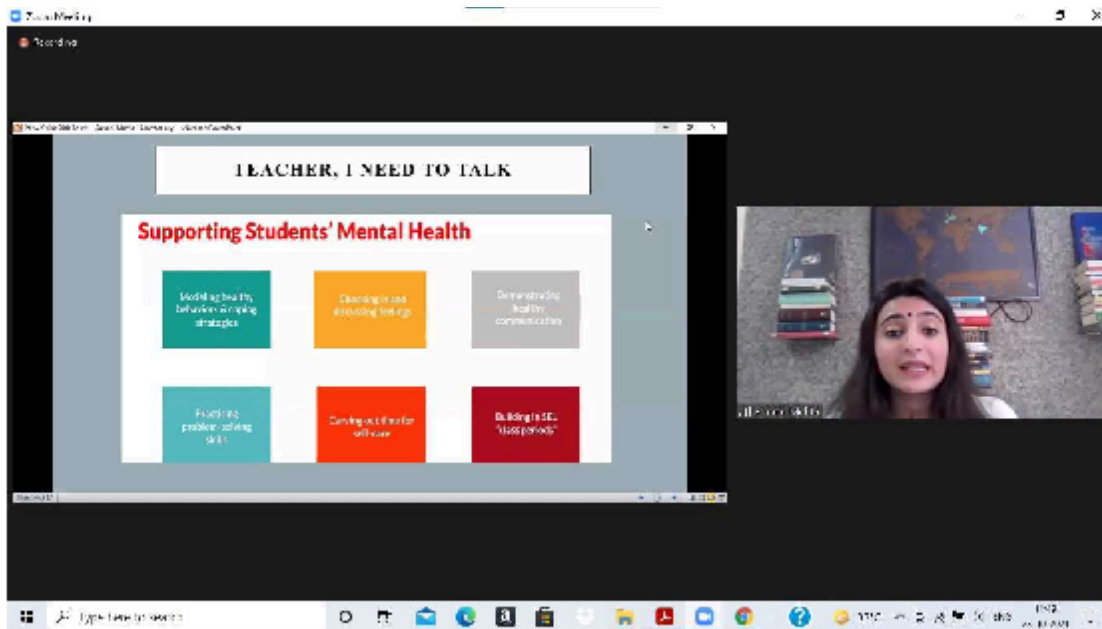




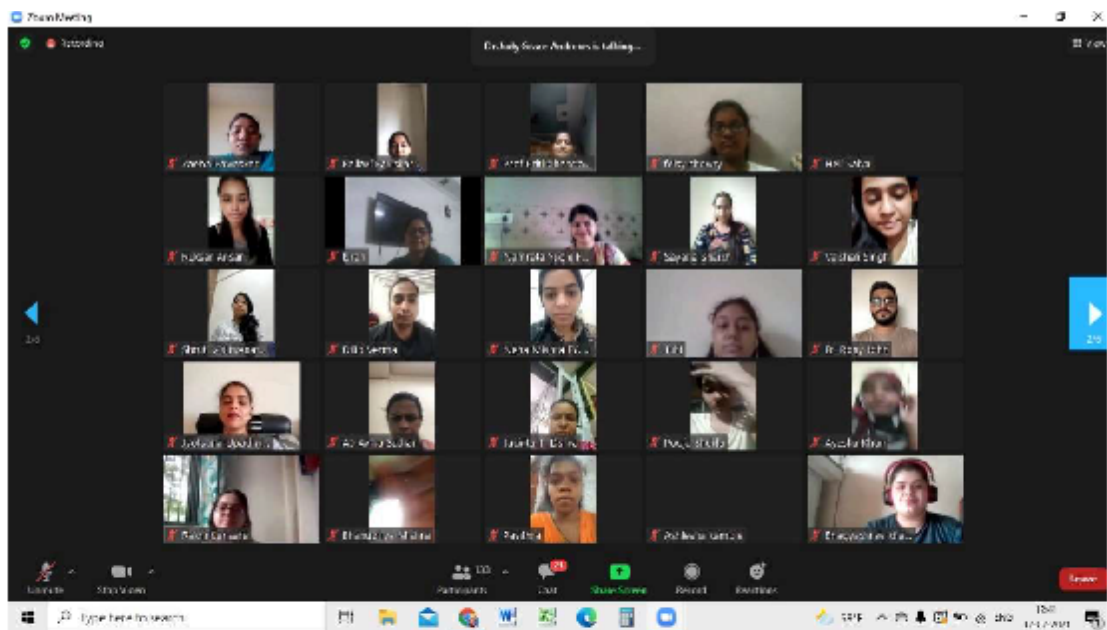
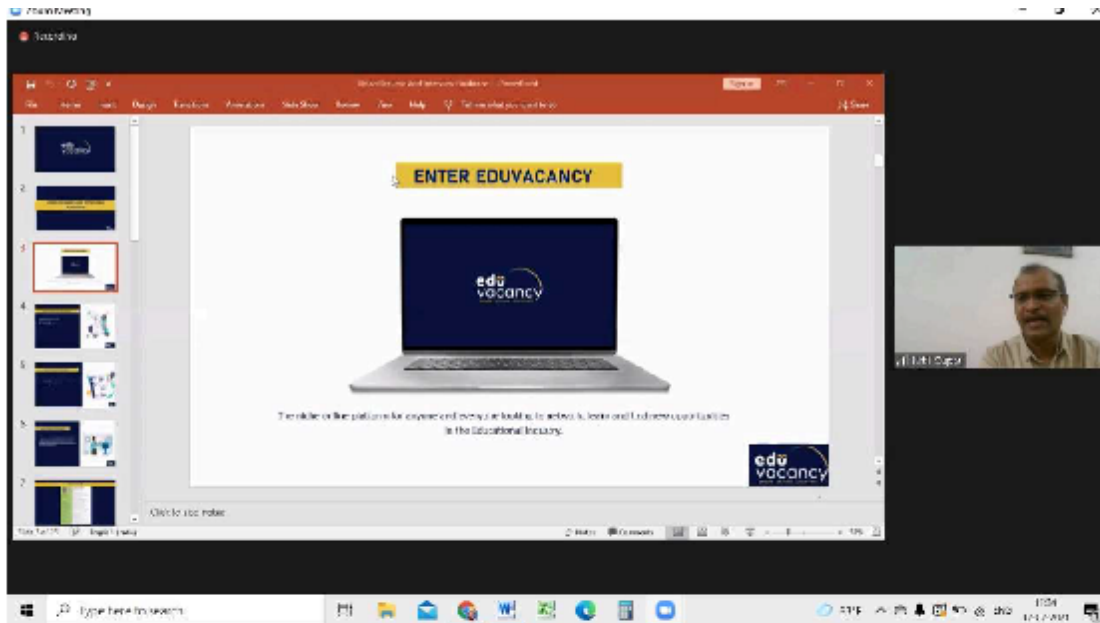
Report of the Placement Cell - 2021-2022

In the year 2020-2021 all the placement activities were conducted online due to Covid - 19 pandemic lock down.

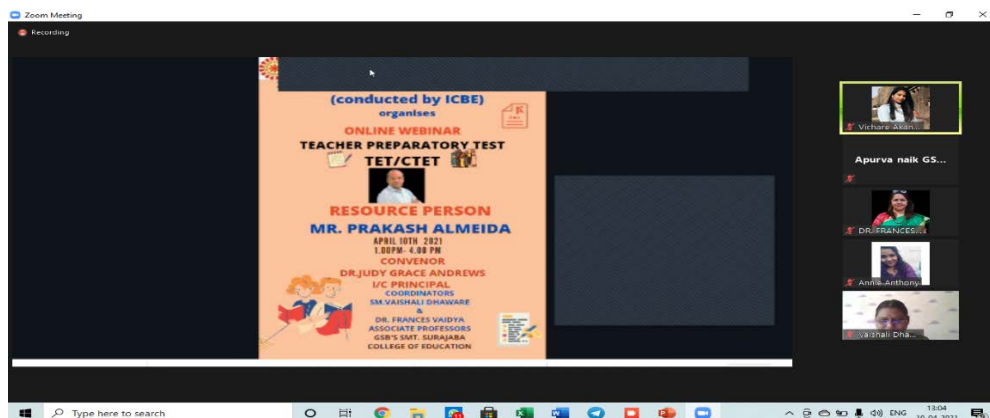

Report of the Placement Cell - 2019-2020

The schools approached college authorities for placements. The placement cell organised expert talks on How to appear for interviews, grooming etc. The placement sessions were organised in the month of January and February 2020. The schools that took part in placement were Arya Vidya Mandir , Potdar International school, Orchid gr. ,kotak Mahindra of schools, Kotak Mahindra etc. The primary interviews were conducted to select students for secondary interviews as well as demonstrations. The students were also recommended for the off campus placements.

However, efforts of placements were standstill due to sudden lock down due to pandemic from the month of March 2020.





Report of the Placement Cell - 2018-2019

A professional course demands placement therefore this portfolio is very important. The college strives hard and makes every effort to place its students. The college undertakes its campus interviews under the placement cell.

This academic year nearly 12 to 15 schools approaches the college for campus placement and the students were also called for direct interviews after posting their bio data.

Placement interviews were carried in different formats. Firstly schools were called for campus mela on 29th January and 2nd February 2019. Nearly 7 schools came for the mela in different sessions.

Witty International School :- 10 students attended the first round out of which 6 were selected for the second round. Finally 3 students got the job with the school.

Dalmia Group of Schools :- 27 students attended the first round out of which 7 were selected for the second round. Finally 2 students got the job with the school.

Orchids International School :- 13 students attended the first round out of which 8 were selected for the second round.

Arya Vidya Mandir Group of Institutions :- 27 students attended the first round out of which 6 were selected for the second round. Finally 2 students got the job with the school.

Akansha NGO :- 25 students attended the first round out of which 8 were selected for the second round.

Aseema NGO :- 24 students attended the first round out of which 2 were selected for the second round.

M-Guru Online Tutorial :- 8 students attended the first round out of which 2 were selected for the second round. Finally 1 student got the job with the school.

Secondly, students were asked to go and report to the schools those were in need of teachers and had approached the college office, principal or the placement teachers.

Thirdly advertisements were posted by teachers in the whatsapp groups when they received it through their references.

Thus, placement cell carried a successful activity wherein nearly, 70 to 80% students got jobs and the other are still in the process.
